

ORDINANCE CONTROLLING DEDICATION OF PUBLIC ROADS IN THE TOWN OF LANARK

Ordinance # 5-77

The Town Board of the Town of Lanark, Portage County, Wisconsin, do ordain as follows:

No road, street or way of travel shall be dedicated, donated or granted to the Town, either within a subdivision or without, unless the same is in compliance with the provisions hereinafter set forth. The Town Board may, but shall not be required to waive all or a part of the requirements hereinafter following.

STREET IMPROVEMENTS. All roads, streets and public ways shall be graded to their full width, including side slopes, and to the appropriate sub-grade, and the traveled roadway 32 feet in width shall be surfaced with a minimum of four inches of road gravel, and the traveled roadway 22 feet in width shall be surfaced with either three inches of a cold-mix or two inches of a hot bituminous substance (blacktopping), all in accordance with applicable specifications of the Town. Said blacktopping shall not be applied to the streets until such time as the four inches of road gravel has laid on the proposed streets for a period of one winter season (winter season defined herein as December 15 through May 31). Such construction shall be subject to the inspection and approval by the Town Board or its designated road superintendent.

STREET DRAINAGE: All necessary facilities shall be installed sufficient to prevent the collection of surface water in any low spot, and to maintain any natural water course. Drainage facilities satisfactory to the Town Board or the designated road superintendent shall be provided for the ends of all cul-de-sacs and dead-end streets.

OTHER REQUIREMENTS. In addition to the above requirements, all roads, streets and public ways shall be constructed pursuant to the provisions of the Wisconsin Statutes, the Wisconsin Administrative Code, and any other lawful governing authority, including other applicable ordinances of the Town of Lanark.

PENALTY. Any person, firm or corporation who fails to comply with any provision of this ordinance, shall upon conviction thereof forfeit not less than \$50 nor more than \$200, together with the costs of prosecution for each violation and in default of payment thereof shall be imprisoned in the County Jail of Portage County, Wisconsin, until payment of such forfeiture and costs but not exceeding 30 days. Each day a violation exists or continues shall constitute a separate offense.

CONSTRUCTION AND EFFECTIVE DATE. The provisions of this ordinance shall be applicable to all streets, roads and ways of travel dedicated to the Town after the effective date of this ordinance. This ordinance shall take effect one day after publication according to law.
